

2010 Annual Report

Our Mission: PET International seeks to reflect the love of Jesus Christ by bringing mobility and dignity to those in developing countries who have lost the ability to walk. Our mission remained strong as we pursued our three main objectives: promotion of PET vehicles, coordinate PET production sites, and assist in the dissemination of vehicles to international agencies/sponsors. These are just some of the accomplishments for this year.

<u>Promotion</u>: Our Executive Director and others continue to promote the need for PET vehicles around the world. This was done in part by making presentations to local churches and organizations. In addition booths were manned at events including Lions Clubs International Convention, Global Missions Health Conference, and Technical Exchange for Christian Healthcare meeting to spread the word of PET's availability. A hands-on production workshop was held at the United Methodist Men's annual event in Nashville, TN.

<u>Coordination of work sites</u>: The assembly sites, Affiliates, were communicated with in various ways. Visits were made at 2 facilities in TX & one in MI. Our annual meeting was held at one of our Affiliates in MO. Two new Affiliates were approved in Reynosa, Mexico, and Rio Grande Valley, TX, for a total of 20 around the world with more in the process of setting up shop.

<u>Dissemination</u>: Our Director of Operations' main task is seeking out new partners and coordinating the distribution our mobility devices. This includes working with trucking firms and international shipping companies. 5,124 PETs were manufactured and 4,941 PETs were distributed by all production sites.

Revenue

PET International, Inc. is a tax-exempt 501c3 nonprofit supported by those who believe in its mission of mobility. This support comes in the form of contributions from individuals, churches, and organizations (including arranging and providing costs for shipping containers of PETs for overseas). Businesses work with us to provide a bulk discount on off the shelf items and discounted shipping prices. Total revenue for fiscal year July 2009 to June 2010 was \$43,388.

Expense

Our major expense is the stipend to our Director of Operations. His contribution has been vital to the growth and success of the whole PET organization. 90% of his time is given to program. We have begun the work of coordinating a major distribution point in Central America working with other NGOs. With funding, we were able to have our first face to face meeting in TX. A total expense for fiscal year July 2009 to June 2010 was \$52,005. Program expense (travel: program, presentation/booth costs, shipping, and reporting materials to tell the story and educate the public) was \$42,868 or 82%. Fundraising expense and Management & General expense (equipment, supplies, phone, travel: business, and office support) was \$9,137 or 18%.


